HOW TO SUPPORT THE PECKHAM CLUB

SINGLE GIFTS

Donations of any amount can be given by cheque or credit/debit card. For credit cards, please complete the authorisation code boxes with the final three digits on the reverse of the card. The issue number is only applicable to Maestro cards.

REGULAR GIFTS

Regular gifts can be made by Direct Debit. Gifts can be made monthly, quarterly or annually. You are protected by the Direct Debit Guarantee which appears on the bottom of the form.

GIFT AID DECLARATION

If you pay UK tax we can reclaim it. The Bradfield Foundation is able to reclaim the tax you have paid on any gift as long as you have paid Income Tax and/or Capital Gains Tax equal to the tax reclaimed in your donation in the tax year. Currently The Bradfield Foundation is able to reclaim 25p from HM Revenue and Customs for every £1 donated and, in addition, HM Revenue and Customs will automatically pay a further 3p of transitional relief for every £1 donated until 5 April 2011. If applicable, please complete the Gift Aid Declaration overleaf.

HIGHER RATE TAX PAYERS

Higher rate tax payers donating through Gift Aid can claim back the difference between the higher rate of tax and the basic rate of tax on the total value of their donation to The Bradfield Foundation via their Self Assessment form.

GIFTS OF SHARES

Share Giving is the most generous tax relief available to benefactors, combining relief on income and capital gains tax. Share gifts qualify for tax relief equal to the market value of the shares on the day the gift is made, including associated costs such as broker fees. The tax relief can be claimed for the year in which the gift is made. Additionally, benefactors do not have to pay any Capital Gains Tax on any increase in the value of the shares since they were bought. Further information is available from the Development Office.
